I. **CALL TO ORDER:** President Anita Patterson called the meeting to order at 9:00 a.m.

### II. PRESIDENT'S ANNOUNCEMENTS/MONTHLY REPORTS:

- A. **Welcome:** The president asked for a moment of silence to remember Carole McClure.
- B. **Minutes:** A motion was made and seconded to accept the February minutes. The Secretary thanked Cathy Reusche for her work in updating the tournament forms for the new local rule pertaining to Ball at Rest Moved Accidentally. She also asked that Reps check their folders at the end of the meeting in case items were added during the meeting. She reported that a sympathy card was sent to Carole McClure's husband.
- C. **Treasurer's Report:** The February monthly statement was accepted after a motion was made and seconded.
- D. **Vice President:** The president requested each rep make sure the Mt. Vintage date has been changed on the calendar she has posted at her club. There was also a discussion about problems incurred when looking at pages on the CSRA website. At times old pages are stored on an individual's computer (cache) and they are not refreshed when the page is next visited. Michelle Randrup will look into settings for alleviating this issue.

### IV. COMMITTEE REPORTS:

- A. **Handicap:** Carrie Dillard has updated the website for the results from The Reserve Club tournament. Only net scores are used for Four-Ball tournaments.
- B. **Rules:** Cathy Reusche has sent Michelle Randrup documents that summarize the penalties and options for various rules infractions. These are concise summaries that everyone can

carry. She also touched upon the proposed rules changes issued by the USGA and the R&A. The USGA website has a blog where feedback can be given.

C. **Team Play:** Team play is back in action. There are two matches left this season, and the race is tight. At Gordon Lakes, were two closest to the pin competitions instead of a 50/50. This was well received and raised around \$200.

D. **Publicity:** Kathy Blackburn will be having knee surgery and needs someone to take over as photographer at Woodside. She will still be able to post the pictures and send publicity information to the newspaper.

**V. New Business:**

**Clarification/wording of Rule 03 on Form FB-1, CSRA WGA Four-Ball Rules Sheet (Revised Feb 2017)** The back of Form FB-1 states that a team will be disqualified if they fail to circle the score used. This is in violation of the Rules of Golf. Cathy Reusche will review it and provide suggested wording at our next meeting.

**VI. ANNOUNCEMENTS:**

These are proposed rules, not new rules. Mary Vaarwerk expressed concern that some players may deem these proposed rules as actual changes.

Anita also asked all reps to provide the names of their assistant reps so we have a more accurate roster and can have name tags prepared. It will also aid in sending documents, such as the agenda and reports, to the appropriate people.

Pat Wilson and Louise Latsko shared their experience volunteering at the 3M Augusta Invitational. They enjoyed the tournament, but were disappointed that the Lady Jag's coach failed to thank the volunteers when she saw them. The players, on the other hand, were profuse in their thanks. The Lady Jags finished third out of eighteen. Pat Wilson will send volunteer information earlier next year.

There is a Lady Jag fundraising tournament for women only on April 14<sup>th</sup>. It is a four-ball tournament with a cost of \$125 per player. Marianne Harris has information for those interested.

Scorers (Susie Meehan, Carrie Dillard and Brooke Hempel) and the Rules officials (Cathy Reusche and the club pros) have been assigned for the Woodside Stroke Play tournament on March 29.
