- Gordon Lakes Mentioned that the new name of the course will be Victory Lake, but no official

- Reserve Club There was an 'error' in the Tournament Fee at the Reserve Club which precipitated the
 discussion on raising the tournament fee. The Reserve Cub 4Ball in July hosted 80 players with no
 cancellations. This number of players highlighted the disparity in the amounts won between overall Gross
 and Net and Flight Gross and Net. This also added to the discussion of distribution percentages.
- Savannah Lakes Nena reported that the opening meeting will be on March 14 (subject to change) and
 the Board Meeting will probably be on Wednesday, March 6. On Mondays the Tara course is closed and
 on Tuesdays, the Tara course is extremely busy since it is the only course open. Keeping with the
 schedule cadence, the first Thursday will not work as it is Savannah Lake's WGA Opening Scramble and
 MGA opener so no tee times would be available.

NEW BUSINESS:

Tournament and Prize Money Distribution

- Discussion on the Prize Money and distribution to individuals was skewed. Louisa shared that the addition
 of \$1 made a difference in the payout. A motion was raised to change the tournament cost to \$7 and was
 agreed upon by Nena, Mara, and Louisa. The vote was unanimous. Also mentioned the form in the
 Tournament Guide will need to be updated.
- A discussion then involved the distribution of tournaments other than Four Ball. All tournaments currently payout 30% overall net and gross with remaining 70% going to the other individuals. This caused a skewed payout for the Reserve Club event. A motion to change all tournaments to reflect the 20% overall net/gross and 80% going to the remaining participants. Nena and Mary Helen raised the motion, and it was approved. Again, this will need to be reflected in the Tournament Guide for 2024.
- Pay Out for Lady Pro is different. Paulette reported that the payout for the past event was \$46 for first place (\$23 each) and \$8 for second place. A motion by Paulette raised the payout for Lady Pro by 25%/15%/10%. Marianne seconded motion and it was approved. Again, the Tournament Guide will need to be updated.
- Louisa then brought up the need for using the forms in the Tournament Guide since Golf Genius takes care
 of the sign ups except for Lady Pro. A motion was raised that the forms be archived in case they need to
 be resurrected. Louisa agreed to review the Tournament Guide information and determine what pertinent
 information needs to remain. Items such as cancellation policy and LadyPro will continue to be at the Reps
 access for planning events. She will provide a proposal at an upcoming meeting.

Document Retention and Destruction Policy

Mary Shultz distributed a proposed Policy for consideration. The proposed policy includes IRS
requirements and accounting guidelines. It was agreed that all members present would review the
document and provide feedback to Mary. A final proposal will be provided so the membership can vote on
this implementation.
